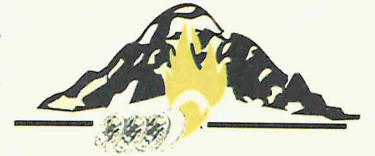

## Eligibility for Membership to the Board and Supervisory

No person shall be eligible for membership of the board of the co-operative society or remain a member of such board if:-

- i. He/she is not an active member of the society for at least two years prior to the Annual Delegates Meeting.
- ii. He/she is not an elected delegate of the society.
- iii. He /she has an immediate member of family as a permanent member of staff.
- iv. He/she is under twenty (20) years of age.
- v. He/ she is not a member of a recognized Christian Church in Kenya
- vi. Has not attained non-withdrawable deposits of Ksh. 750,000 and share capital of Ksh. 30,000 or as may be resolved by ADM
- vii. He /she does not have a valid certificate of good conduct.
- viii. He /She is unable to provide a clearance certificate from Credit Reference
- ix. He/ she does not have an introductory letter from A.C.K parish vicar or a recognized church leader for the open bond position
- x. He/she is not available to serve.
- xi. He/she receives any remuneration, salary, or other payment from the society in accordance with the Act.
- xii. He/she is an undischarged bankrupt.
- xiii. He/she is certified to be of unsound mind.
- xiv. He/she has been adversely named by the Commissioner for Co-operative Development or his/her representative in any inquiry report endorsed by an annual or special delegates meeting for mismanagement or corrupt practices while still a member of the board of directors of a co-operative society or union.

- xv. Has been adversely named by the Authority in an inspection report for mismanagement or corrupt practices while still a member of the board of a Sacco society.
- xvi. He/she has been convicted of any offence involving dishonesty or is imprisoned for three months or more.
- xvii. He/she has been convicted of any offence under the Act or rules made there under.
- xviii. Is not an active member of the society and whose monthly saving and loan repayments have not been contributed to the society for a period of two months.
- xix. He /she does not have 0 level as the minimum level of education for the new entrants with exemption given to the existing board members due to trainings undergone and the exposure in the Sacco business hence their qualification remains and able to read, write and speak English
