- Members will be admitted on payment of registration fee of Kshs. 500 (payable once) and payment of minimum deposit of Kshs. 1,500 (Ksh. 1000 for normal savings & Ksh. 500 for share capital)
- Members should purchase a minimum of 200 shares at a cost of Kshs. 100 per share (Ksh. 20000) with a period of 3 years and 4 months from date of registration (Share Capital)
- Members may be part of a cell group of at least 5 members and a maximum of 20 members or have collateral as an individual to get BOSA loans.
- Members can receive up to 80% of their share deposit as a loan (Ownshare).
- FOSA loans will be self-guarantee with deposits and/or collateral.
- After six months membership, a member will qualify to receive a loan of up to 3 times their savings for the first loan and 4 times their savings for subsequent loans.
- All BOSA loans are secured by guarantee from other cell group members and/or collateral.
- Loans are repaid within 6 months up to a maximum of 72 months depending on the loaned amount and product.
